Contest Rules

CONTEST DURATION

The "Win Your Scholarship" contest (hereinafter the "Contest") is organized by Caisse Desjardins de Vaudreuil-Soulanges (hereinafter the "Organizer") and will be held from 16/10/2023 - 00:01 EDT to 30/11/2023 - 23:59 EST (hereinafter the "Contest Period").

ELIGIBILITY

This contest is open to anyone who, in their province of residence, is:

- aged 16 and over as at 16/10/2023;
- a full-time student in a high school, vocational, college or university program recognized by the Ministère de l'Éducation et de l'Enseignement supérieur du Québec for the fall or winter term for the year 2023-2024;
- A member¹ of the Caisse Desjardins de Vaudreuil-Soulanges.
- A Québec resident.

(Hereinafter the "Eligible Participant").

Exclusions

The following are not eligible for the contest:

- Employees, executives, directors and officers of Caisse Desjardins de Vaudreuil-Soulanges, members of their immediate families (brothers, sisters, children, father, mother), their legal or common-law partner and the persons with whom they are domiciled;
- Employees, executives, directors and officers of the Fédération des caisses Desjardins du Québec, Caisse Desjardins Ontario Crédit Union inc., the Fédération des caisses acadiennes, their member caisses or any other Desjardins Group entity, members of their immediate families (brothers, sisters, children, father, mother), their legal or common-law partner and the persons with whom they are domiciled;

¹ By definition, a Desjardins member is a person with an account in a Desjardins caisse affiliated with the Fédération des caisses Desjardins du Québec or, for the purposes of this contest, a member of Caisse Desjardins Ontario Crédit Union Inc. A member or associate must have received confirmation from an authorized representative of Desjardins that the account was opened.

- Employees, executives, officers and directors of the agencies and/or service companies involved in carrying out this contest, members of their immediate families (brothers, sisters, children, father, mother), their legal or de facto spouses, and persons with whom they are domiciled;

HOW TO ENTER.

Sweepstakes

To participate, eligible participants must, during the Contest Period:

- Go to the website [Vaudreuil-Soulanges Desjardins Student Scholarships \(gagnetabourse.ca\)](http://Vaudreuil-Soulanges Desjardins Student Scholarships (gagnetabourse.ca)) and fill in the information requested on the entry form;
- Submit the entry form / application between **16/10/2023 - 00:01 EDT** and **30/11/2023 - 23:59 EST**;

No purchase or payment is required. To participate in the contest without purchase or any other obligation, eligible participants must legibly handwrite their first and last name, address (including the city and postal code), telephone number, date, and write a text of approximately 500 words on "your dream" and mail it in a sufficiently stamped envelope to the following address: 455, avenue Saint-Charles, Vaudreuil-Dorion, Québec, J7N 2N4, to the attention of Nadine Tousignant. Entries without purchase or payment must be posted no later than the last day of the contest, i.e. by 30/11/2023 - 23:59 EST (as evidenced by the postmark), otherwise entries will be considered void. Upon receipt of the letter, participation in the contest will be automatically recorded and will give you a chance to win. One duly stamped envelope entitles the holder to one entry only. Entries received this way are subject to the same conditions as those applicable to other entries received in this contest. Mechanical reproductions are not accepted. Entries become the property of the Organizer and will not be returned.

Limit of one (1) entry per Eligible Participant, regardless of the method of entry used.

PRIZE

Anything not described above is not included in the prize and is the responsibility of the winner.

The winner will assume alone the taxes that may result from the awarding of the prize, to the full exemption of the Organizer and the persons for whose benefit this contest is held.

The prize will be deposited to the everyday chequing account held in the name of the recipient at Caisse Desjardins de Vaudreuil-Soulanges or by cheque in the name of the recipient, according to the participant's preference.

DRAW/SELECTION

The winner will be determined by a random draw that will be carried out manually. The draw will take place on 5/12/2023 at 3:00 pm EST, in the presence of witnesses, at the Organizer's premises, at the Centre de services St-Charles, 455, avenue Saint-Charles, Vaudreuil-Dorion (Québec) J7V 2N4.

The odds of winning depend on the number of valid entries received during the Contest Period.

TERMS & CONDITIONS

In order to be declared a winner, the selected Eligible Participant must:

- a) be reached by a representative of the Organizer by email within (2) days after the contest draw date. The selected Eligible Participant must be reached within a maximum of 3 attempts and will have a maximum of (48) hours to respond to the message left by the Organizer, if applicable, failing which they will lose their right to the prize. The prize will then be awarded to the next participant, whose name will have been drawn, and the same procedure will be followed until a winner is chosen;

or

In the case of a minor participant, be contacted by a representative of the Organizer who will contact a parent or legal guardian of the selected minor participant by email within (2) days after the contest draw date. The parent or legal guardian of the selected Eligible Participant must be reached within a maximum of 3 attempts and will have a maximum of (48) hours to respond to the message left by the Organizer, if applicable, failing which the selected participant will lose their right to the prize. The prize will then be awarded to the next participant, according to the selection process defined in these Contest Rules, and the same procedure will be followed until the winner is chosen.

- b) confirm that they meet the eligibility requirements and other requirements of these Contest Rules;
- c) at the request of the Organizer, provide proof of study for the current year;
- d) answer correctly, without help and within a limited time, a mathematical skill-testing question that will be asked to complete by email.
- e) sign the Declaration and Liability Waiver form (hereinafter the "Declaration Form") which will be sent by email. The Eligible Participant must return it to the Organizer within 10 business days of receipt. The parent or legal guardian will sign the declaration form if the selected participant is a minor.
- f) be present at the prize-giving ceremony.

For failure to comply with any of the conditions mentioned above or any other condition mentioned in these rules, the selected Eligible Participant will be disqualified, and, at the discretion of the Organizer, the prize will either be cancelled or a new draw for the prize will be made in accordance with these Contest Rules until a participant is chosen and declared the winner of that prize. The same applicable conditions will then remain by making the necessary adaptations, if any.

- 1. Presentation of the prize.** Upon receipt of the Declaration Form and within fifteen (15) days, the Organizer will inform the winner of the terms and conditions for taking possession of the prize. In the event of a refusal to take possession of the prize, the Organizer will be released from any obligation relating to the delivery of the prize to the selected Eligible Participant and may, at its discretion, cancel the prize or draw it again in the manner described in the previous paragraph.

If the winning Eligible Participant is a minor and resides in Québec, the prize may only be claimed by the person entered in the contest with the written consent of one of their parents or their guardian who will confirm the age of the Eligible Participant, that the latter meets all the conditions of the contest and will release the Organizer and the persons for whose benefit this contest is held, from any liability for any damage or loss arising from participating in this contest, the awarding or use of the prize, its quality, any defect in the prize or its loss in transit, by signing the Declaration Form.

- 2. Verification.** All entries and Declaration forms may be subject to verification by the Organizer. Those that are incomplete, inaccurate, illegible, mechanically reproduced, damaged, fraudulent, filed or transmitted late, with an invalid or otherwise non-compliant telephone number, may be rejected and will not be eligible for the prize.
- 3. Disqualification.** Any person participating in this contest or attempting to participate in it by a means contrary to these rules and likely to be unfair to other participants (example: hacking, use of a "voting group," use of a nominee) will automatically be disqualified and may be referred to the competent judicial authorities.
- 4. Conduct of the contest.** Any attempt to sabotage the legitimate conduct of the contest is a violation of civil and criminal laws. If such attempts are made, the Organizer reserves the right to reject the Eligible Participant's entries and obtain redress under the law.
- 5. Participant's identification.** For the purposes of these rules, the Eligible Participant is the person whose name appears on the entry form and who complies with the conditions set out in these rules. The prize will be awarded to that person if they are selected and declared the winner. If a dispute arises regarding the identification of the person who completed the entry form, the entry form will be considered to have been sent by the authorized account holder associated with the email address provided at the time of entry, if any. The "authorized account holder" means the natural person who is assigned an email address by an Internet service provider or other company assigning email addresses for the domain associated with the submitted email address.
- 6. Acceptance of prizes.** The prizes must be accepted as described in these rules and may in no case be transferred in whole or in part to another person, replaced and/or exchanged for another prize, subject to what may be decided, in its sole discretion, by the Organizer.
- 7. Limitation of liability.** If the Organizer cannot award the prize as described in these rules, it reserves the right to award a prize of the same nature and equivalent value or, at its sole discretion, the value of the prize indicated in these rules. In all cases, the Organizer may not be held to award more prizes or to award a prize other than in accordance with these

rules. If the number of prizes offered is greater than the number of Eligible Participants, the Organizer reserves the right to cancel the excess prizes.

- 8. Limitation of Liability – use of the prize.** The winner releases the Organizer and the persons for whose benefit this contest is held from any liability for damages that may arise from their participation in the contest, acceptance and use of the prize. The winner acknowledges that from the receipt of the prize by the Organizer, the performance of the obligations related to the prize becomes the entire and exclusive responsibility of the suppliers of products and services. The winner undertakes to sign a Declaration Form for this purpose. The winner of a prize acknowledges that the only warranty applicable to the prize is the usual manufacturer's warranty.
- 9. Limitation of liability – operation of the contest.** The Organizer and the persons for whose benefit this contest is held disclaim any responsibility for the malfunction of any computer component, any software or any communication line, for the loss or absence of network communication or for any defective, incomplete, incomprehensible or erased transmission by any computer or computer network, and which may limit or prevent any person from reading the rules of participation. They also disclaim any liability for any damage or loss that may be caused, directly or indirectly, in whole or in part, by the downloading of any Internet page or any software or other and by the transmission of any information related to participation in the contest. In particular, if the administration, security, fairness, integrity or proper conduct of the contest is corrupted or seriously affected, in particular due to viruses, bugs, alterations, unauthorized accesses, fraud or computer technical failures or any other cause, the Organizer reserves the right, without prior notice, to cancel, modify, postpone or suspend the contest.
- 10. Limitation of Liability – Facebook.** As the contest is hosted by Facebook, participants acknowledge and agree that the Facebook site is not owned or operated by the Organizer. Nevertheless, they acknowledge that they are subject to Facebook's terms of use. The personal information collected as part of this contest is for the exclusive use of the Organizer and will not be communicated in any way to Facebook. The contest is not sponsored, endorsed or administered by Facebook or in any association with Facebook. No liability can be attributed to Facebook. In addition, by entering the contest, contest participants confirm that they indemnify Facebook and hold the company harmless from any liability or claim for damages arising from their participation in the contest.
- 11. Limitation of liability – receipt of entries.** The Organizer and the persons for whose benefit this contest is held will not be liable for any lost, misdirected or late entries, including due to a problem with the postal service or any failure for any reason whatsoever of the website during the term of this contest, including any damage to a participant's computer or mobile device.
- 12. Limitation of liability – situation beyond control.** The Organizer and the persons for whose benefit this contest is held will not assume any liability of any nature whatsoever in any case where their inability to act results from a fact or situation beyond their control or from a strike, lockout or any other labour dispute in the establishments of the bodies or companies whose services are used to hold this contest.
- 13. Modification of the contest.** The Organizer reserves the right, in its sole discretion, to cancel, terminate, modify or suspend, in whole or in part, this contest in the unlikely case of an event or any human intervention that may alter or influence the administration, security, impartiality or conduct of the contest as provided for in these rules. No liability can be attributed to the Organizer.

- 14. End of participation in the contest.** In the event that, for any reason whatsoever, participation in the contest was to end in whole or in part before the end date provided for in these rules, at the discretion of the Organizer, the award may be made from among the entries duly registered and received up to the date of the event that terminated participation in the contest.
- 15.** In all cases, the Organizer may not be held to award more prizes or to award a prize other than in accordance with these rules.
- 16. Limitation of liability – participation in the contest.** By participating in or attempting to participate in this contest, any person releases the Organizer and the persons for whose benefit this contest is held from any liability and any damage that they may suffer as a result of their participation or attempted participation in the Contest.
- 17. Communication with Participants.** No communication, commercial or otherwise, not related to this contest will be sent to the participant unless they have expressly consented to such communication. Any communication or correspondence will be made solely in connection with this contest in accordance with these rules, at the initiative of the Organizer or to obtain the consent from the Eligible Participant for the use of their entry text without purchase or consideration.
- 18. Copyright.** Eligible Participants consent to the Organizer's free use, production or reproduction for internal purposes in Canada, without time limits, in whole or in part, of the text submitted for the purposes of the contest without any obligation for the Organizer to cite the name of the author of the text. Eligible Participants also agree that the Organizer may proceed with the translation of the text without the need to obtain the authorization of the Eligible Participants regarding the accuracy and precision of the translation. Eligible Participants also agree that, if necessary, the Organizer may correct the spelling of the text.
- 19. Personal information.** To enter the Contest, we must collect, use, and share personal information about you. For more details, see the Desjardins Group Privacy Policy at www.desjardins.com/privacy-policy.

By entering the contest, the participant authorizes the Organizer or its authorized agents to collect, use and disclose their personal information for the purpose of administering the contest and awarding prizes in accordance with applicable regulations and its Privacy Policy.

22. Decisions. Any person who participates in the contest agrees to comply with these rules and the final and unappealable decisions of the Organizer who administers the contest.

23. If any paragraph of these rules is declared or held to be illegal, unenforceable or void by a court of competent jurisdiction, then such paragraph shall be deemed void, but all other paragraphs shall remain applicable to the extent permitted by law.
